Use or Lost Revenue? When your vehicle is damaged by an at fault driver, it is the use value that is compensable. It is equivalent to the person that has a weekend convertible. Even though he has an extra car, he is still entitled to a rental car. Same principle of law applies.

What if our Fleet Has PhysicalD amage Coverage?

The ACM program enhances your insurance coverage. You can still have your carrier handle the damages if you chose to while ACM handles the loss of use/lost revenue and diminution of value claim. ACM does not charge you to recover your repair costs and your carrier cannot recover the loss of use/lost revenue and diminution of value claim because they are not covered elements under a physical damage policy.
